

1-Year Limited Manufacturing Warranty on Wire & Cable Products

Re: Limited Warranty on All Wire & Cable Products

For any wire and cable products supplied by Southwire Company, LLC, our standard manufacturing limited warranty is one year from the date of the original end user's purchase or date of delivery (if later than the date of purchase).

Southwire warrants: all products manufactured by Southwire will materially conform to the specifications provided by Southwire and will be free of defects in material and workmanship ("Defects") for the duration stated above, under normal use and regular service and maintenance, and if installed pursuant to Southwire's instructions. The sole and exclusive remedy under this warranty for a Defect found and reported within the warranty period, shall be at Southwire's sole discretion, to repair, replace or refund the defective product (if repair or replacement is not possible). Under this Limited Warranty for Wire and Cable Products, the following are excluded and Southwire Company, LLC will have no liability for any of the following: (i) has been repaired or altered by someone other than Southwire without the express, written consent of Southwire; (ii) has been subject to misuse, improper storage (including where stored in excessively hot or cold conditions), abuse, neglect, intentional misconduct, accident, customer, user or third-party negligence, unauthorized modification or alteration, use beyond rated capacity, a force majeure event, or improper or inadequate maintenance; (iii) is composed of materials provided by, or designed and/or manufactured pursuant to instructions from the customer; (iv) has failed due to ordinary wear and tear; (v) has been exposed to adverse operating or environmental conditions; or (vi) has been maintained or used not in accordance with the applicable owner's or operator's manual or other similar instructions.

The warranty extends only to the original end user purchaser and is non-transferable.

For the United States Only: Because Southwire cannot control the quality of products sold by unauthorized sellers, this warranty applies only to Products that were purchased from Southwire or a Southwire authorized seller in the United States, unless otherwise prohibited by law.
